



CHAPTER DEGREE

Eligibility for the Chapter Degree:

- The Chapter Degree is designed to promote individual growth.
- Any affiliated high school member may earn the Chapter Degree.
- The Chapter Degree is one of two options that must be completed before earning the State Degree.
- Must complete one semester of high school Family and Consumer Sciences course or related career field course.
- Must be awarded before June 1st, if the member plans to work toward the State Degree.

Guidelines for the Chapter Degree:

- Evidence can include but not limited to photos, newspaper articles and thank you notes.
- All documentation must be placed in a secure binder.
- A variety of persons must be used for signatures. Chapter adviser can only be used for three activities or events.
- Must show evidence for each activity or event.
- Must secure signatures of appropriate persons to verify the activity or event.
- Integrate class activities to meet degree requirement.
- Degree candidate should develop and implement each event and/or activity.

Clarification:

- Sample activities or events that could be used
 - Individual
 - Personal goal
 - Family
 - Become a responsible family member
 - Help improve the relationship between family members
 - Teach adult living skills to family members
 - FCCLA Chapter
 - Develop leadership by assuming chapter responsibilities
 - Carry out responsibilities as a chapter officer
 - Participate in career development event
 - Help acquaint new members with FCCLA
 - School
 - Become responsible for a school project
 - Help improve a relationship between students and faculty
 - Attend and participate in school organizations
 - Community
 - Become a well-informed member of the community
 - Become involved as a community member
 - Become involved in a community event or activity
 - Careers
 - Participate in a career development event at the local level or above
 - Promote Family and Consumer Sciences Education or related career field
 - Develop a promotional item with facts contributing to FCS Education or related career field

Granting of Chapter Degree:

- Local chapters may grant the Chapter Degree to those members who fulfill the standards.
- Local chapters should develop and implement an evaluation process.
- The local chapter is responsible for keeping records of all degrees granted.
- Local chapters are expected to secure proper forms for degree candidates.
